We currently serve Lincoln County, North Carolina and the surrounding areas. As we grow, we will expand our service area to North Carolina, the southeast, and the entire U.S.

## Did you know...

#### **Clothing Waste**



In 2018, 17 million tons of textile waste was generated in the U.S. Of that, 2.5 million tons was recycled, 3.2 million tons was combusted and 11.3 million tons was landfilled.

#### Homelessness

According to the HUD Homelessness Assessment for 2022. there were at least



3,625 unsheltered homeless persons in North Carolina. Statewide there is an estimated total of 9,382 homeless people – 2,730 families with children and 6,652 individuals with a total of 5.757 people sheltered. We could find no official count for our immediate area but it's far too high.

#### Foster Children



In February 2023, WBTV Charlotte reported that there are over 12,000 children in foster care in North Carolina.

There are less than 6.000 licenses foster homes in the state and some children are having to sleep in social services offices and local jails.



#### When items come in...

We take corporate-branded clothing (SWAG) and employee uniforms that cannot be donated anywhere and we decommission them. We remove embroidered and heat-transfer logos and replace them with a different image.

This allows us to save a mountain of items from landfills and get them to those who need them.

#### Where they go...

Once we have removed logos and laundered and added a new image, we distribute items to ministries and organizations that serve our target constituents. We also provide direct aid when we can. Seasonally appropriate garments are distributed according to need.



## What we need

We take a variety of items that cannot be donated elsewhere. We can make use of the following:

- Corporate clothing (SWAG) items with employer and/or corporate logos
- Employee uniform shirts and pants, jackets, coats, rain gear, etc.
- Gloves, hats, scarves
- Blankets
- New and gently used boots, shoes, sneakers (useful items...nothing designer) and laces
- New socks and undergarments
- Money we manage *every penny* but it takes a lot of them

We will also take bulk fabrics like fleece and flannel that we can transform into needed items like blankets and scarves.
